TRADITIONAL AND COMPLEMENTARY MEDICINE ACT 2016

TRADITIONAL AND COMPLEMENTARY MEDICINE (RECOGNIZED PRACTICE AREAS)  
ORDER 2017

IN exercise of the powers conferred by subsection 20(2) of the Traditional and Complementary Medicine Act 2016 [Act 775], the Minister, after considering the recommendation of the Council, makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Traditional and Complementary Medicine (Recognized Practice Areas) Order 2017**.

(2) This Order comes into operation on 1 August 2017.

**Recognized practice areas**

2. The Minister prescribes the practice areas specified in the Schedule as the recognized practice areas.

2. Traditional Chinese medicine
3. Traditional Indian medicine
4. Homeopathy
5. Chiropractic
6. Osteopathy
7. Islamic medical practice
